#### RESOLUTIONS FOR THE 152ND ANNUAL SESSION OF THE MASSACHUSETTS STATE GRANGE

#### 1. SUPPORTING COMPENSATION FOR GUARDIANS AND SPOUSES AS CAREGIVERS

WHEREAS, caregiving plays a vital role in supporting individuals who require assistance due to age, illness, or disability; and

WHEREAS, guardians and spouses often undertake caregiving responsibilities, dedicating significant time, effort, and resources to provide care for their loved ones; and

WHEREAS, caregiving duties can be financially burdensome, resulting in caregivers sacrificing their own professional opportunities, income, and retirement savings to fulfill their responsibilities; and

WHEREAS, compensating guardians and spouses as caregivers acknowledges the invaluable contribution they make to the well-being of their dependents and recognizes the importance of their role in society; and

WHEREAS, providing financial support to caregivers can alleviate economic strain, reduce caregiver burnout, and ensure the continuity and quality of care provided to those in need; therefore, be it

RESOLVED, that the Massachusetts State Grange support MA Bill S67/H216 An Act Allowing Spouses to Serve as (paid) Caregivers; and be it further

RESOLVED, that the Massachusetts State Grange encourage members to contact their local legislators requesting co-sponsorship and, if possible, provide personal stories how the legislation would benefit their families.

# 2. ENHANCING ACCESS TO TRANSPORTATION FOR RURAL SENIORS TO MEDICAL APPOINTMENTS BEYOND THEIR LOCAL AREA

WHEREAS, seniors often face significant challenges in accessing transportation services, particularly for essential trips such as specialized medical appointments; and

WHEREAS, access to transportation services is limited for seniors due to factors such as geographical isolation, lack of public transportation infrastructure, lack of social and familial support systems, lack of insurance coverage for transportation, and limited availability of affordable options; and

WHEREAS, providing convenient and affordable transportation options can help alleviate isolation and improve access to specialized healthcare services among seniors; and

WHEREAS, seniors must travel as far as one hundred miles or more to obtain expedient, specialized care; therefore, be it

RESOLVED, that the Massachusetts State Grange encourages the Commonwealth of Massachusetts to create a comprehensive Senior Transportation Initiative. This initiative will:

Create equitable access to transportation services for seniors across the Commonwealth, to medical services statewide and throughout New England. This initiative shall include the development of specialized transportation programs tailored to the needs of seniors.

Expand existing transportation options, such as shuttle services, rideshare programs, and volunteer driver networks, to better serve senior populations and provide them with convenient and affordable transportation alternatives to medical appointments.

Subsidize transportation programs specifically targeted toward all seniors, providing discounted fares or vouchers to alleviate the financial burden associated with transportation costs.

Ensure that transportation services are accessible and accommodating to the unique needs of seniors, including wheelchair accessibility, mobility issues, door-to-door assistance, and scheduling flexibility."

#### 3. REGARDING FAMILY MEMBERSHIP

WHEREAS, the National Grange has included legal dependents of any age in their legal guardians' family under family membership; and

WHEREAS, many family households include disabled adult relatives who have no legal guardians; and

WHEREAS, these disabled adult relatives may have limited income and resources; therefore, be it

RESOLVED, that the National Grange amend the Digest of Laws article 4.6.6 (B) to allow disabled relatives of any age who live as a member of the same household to be included in the Grange's family membership; and be it further

RESOLVED, that article 4.6.6 (B) be amended as follows:

Delete the words "are defined as" in the second sentence and replace them with "shall include", and delete the third sentence "Legal dependents of any age shall be considered part of their legal guardians' family." and replace it with "Dependents shall also include disabled relatives of any age who live as a member of the same household." so that the amended paragraph will read as follows:

(B) A family shall consist of a couple and their dependents, or a single person and their dependents. Dependents shall include children, grandchildren, great grandchildren, foster, adopted or step-children under the age of 23, who live as a member of the same household or in absence due to illness, education or military service. Dependents shall also include disabled relatives of any age who live as a member of the same household.

### 4. MEMBERS RESIDING IN LONG TERM CARE FACILITIES

WHEREAS, Subordinate and Pomona Grange members are required to pay annual membership dues; and

WHEREAS, some Grange members reside in long term care facilities; and

WHEREAS, many of these Grange members usually have limited assets; and

WHEREAS, until the year 2000, the National Grange and State Granges did not charge dues to Golden Sheaf members; therefore, be it

RESOLVED, that the National Grange amend the Digest of Laws article 6.6 HONORARY MEMBERSHIP by inserting the following paragraph:

6.6.4 Upon authorization of a State Grange, a Subordinate Grange within its jurisdiction may relieve a Grange member or members residing in long term care facilities from payment of Subordinate, Pomona, or State dues. and be it further

RESOLVED, that these members will continue to enjoy the rights, privileges, and responsibilities of Grange membership.

### 5. THE BIBLE UPON THE ALTAR

WHEREAS, the National Grange's Commitment to Inclusion states "We have always welcomed and invited people of all races, creeds, religions and nationalities into our membership"; and

WHEREAS, the last paragraph in the Vision Statement of The National Grange states "As the premier progressive family fraternal organization, the National Grange is dedicated to using its solid, historical foundation to advance a widely recognized, welcoming, and cooperative Order that empowers people to pursue their ideas of entertainment, education, and enlightenment for all who desire to benefit."; and

WHEREAS, C. Jerome Davis, as Field Assistant to the National Master, once wrote "The teachings of the ritual enable our Order to be political without being partisan, religious without being denominational, and though it

binds its members with a strong fraternal tie, it assures a complete individuality."; and

WHEREAS, the Bible on the Altar and references to God make it appear that the Grange is only of Christian faith and not welcoming to non-Christian denominations and may offend those who are not Christians; therefore, be it

RESOLVED, that the National Grange amend the Digest of Laws article 11.8.3 by inserting, "and/or another spiritual book or text," between the words "Bible" and "open", so that the amended article shall read:

11.8.3 All Granges shall have the Bible and/or another spiritual book or text, open on the altar and the flag of the United States of America properly displayed in the Grange meeting room.

### 6. ROLL CALL OF OFFICERS PROCEDURE

WHEREAS, the Massachusetts State Grange uses a traditional gender-specific procedure for the Roll Call of Elected State Officers, the Roll Call of Appointed Officials, and the Roll Call of Youth Officers, that is the Assistant Steward reports for the males and the Lady Assistant Steward reports for the females; and

WHEREAS, there are subordinate Grange members in Massachusetts who do not identify with either the male or female genders; and

WHEREAS, Grange is an inclusive and progressive organization which respects all members' beliefs; and WHEREAS, the National Grange uses a procedure that is not gender-specific by having the officials report themselves as being present during the Roll Calls; therefore, be it

RESOLVED, that the Massachusetts State Grange use a procedure that is not gender specific to report on the attendance of its elected and appointed officials.

### 7. DISTRIBUTION OF NATIONAL GRANGE MAILING LIST

WHEREAS, recently members have received letters from insurance companies bearing the National Grange logo attempting to sell policies to members; and

WHEREAS, while the purpose of these letters is not nefarious, its receipt caused questions and alarm among some members about the use of the National Grange mailing list by outside companies; and

WHEREAS, nowhere on the membership application does it ask members if they wish to receive marketing messages from outside companies and thus the membership roster should only be used for Grange related mailings and information and not be used by outside companies to sell anything; and

WHEREAS, the National Grange Digest gives the National Grange Master and the National Executive Committee the power to use the mailing list at their discretion with no restrictions; therefore, be it

RESOLVED, that Section 9.9 RESPONSIBILITY OF MAILING LISTS of the National Grange Digest of Laws be amended to read:

"9.9.2 Grange members must be given the opportunity to opt out of receiving promotional material in the mail from companies or partners that are not directly sent by the National Grange. This is not to preclude members from receiving mailings from the National Grange.

9.9.3 All communications received by members from outside companies or partners that have received authorization from National Grange to use the mailing list must bear the National Grange logo and have the following disclaimer: 'This communication has been approved by the National Grange Master/President/Executive Committee.'

9.9.4 All State Masters must be notified of mailings going out to members at least 10 days before the mailing to ensure there is proper communication and to allow them to answer questions, if they arise from members, on the validity of the communication. "And be it further,

RESOLVED, that this resolution be forwarded to National Grange for their consideration.

### 8. INCREASING PROPERTY AND LIABILITY INSURANCE PREMIUMS

WHEREAS, Insurance companies have increased the premiums of both property and liability insurance a substantial amount over the last couple of years;

WHEREAS, Granges that own their halls have found that the increases in premiums have made it financially hard to pay for insurance;

WHEREAS, the additional costs associated with a cruise ship venue would likely reduce the number of delegates and members able to attend, thus limiting participation and representation at the National Grange Session; and WHEREAS, the mission of the National Grange includes fostering a strong sense of community and ensuring that all members have the opportunity to engage in its activities and governance processes; therefore, be it RESOLVED, That Article 4.9.5 of the National Grange Digest be amended to add to the end of the first paragraph the phrase "in a location within the borders of the United States that is affordable and accessible to members," ensuring that future National Grange Sessions are held in a manner that supports maximum member participation and minimizes financial burdens on delegates and members; be it further

RESOLVED, that this resolution be forwarded to National Grange for their consideration.

WHEREAS, the Massachusetts State Grange recognizes the importance of providing students with the tools and training they need to succeed in high-demand, high-skill industries; therefore, be it

RESOLVED, that the Massachusetts State Grange supports the use of hoisting equipment in Chapter 74 vocational technical education; and be it further

RESOLVED, that the Massachusetts State Grange urges the members of the Massachusetts General Court to pass legislation to enhance the quality and scope of vocational technical education in the Commonwealth.
